

## L-AVVIŽ DWAR IL-PRIVATEZZA

Bis-sottomissjoni tal-Formola Dwar l-Istat Liberu flimkien ma' dokumenti neċċesarji oħra annessi magħha, inti qed tiprovd i l-Aġenzija Identità Malta (IMA) b'informazzjoni personali, u għalhekk issir suġġett għad-data. L-ghan ta' dan l-avviż dwar il-privatezza, huwa sabiex inkunu konformi mal-obbligli ġusti u transparenti taħt ir-regolamenti ġenerali dwar il-protezzjoni tad-data, u biex ninfurmawk dwar min se jkun qed jipproċessa l-informazzjoni tiegħek, għal liema għan, għal kemm żmien se tinżamm, ma' min se tkun qed tinqasam u dwar id-drittijiet tiegħek bħala suġġett għad-data taħt ir-regolamenti ġenerali dwar il-protezzjoni tad-data.

IMA se tapplika miżuri adegwati sabiex tiproteggi d-drittijiet, il-libertajiet u l-interessi leġittimi ta' dawn l-individwi.

### 1. Ufficijal għall-Kontroll tad-Data u Protezzjoni tad-Data

L-Aġenzija Identità Malta hija l-kontrollur tad-data, li jfisser li hija l-entità li tistabbilixxi l-għanijiet u l-mezzi li bihom tiġbor u tipproċessa l-informazzjoni tiegħek b'rabta ma' din il-formola.

L-Aġenzija Identità Malta hija aġenzija tal-Gvern ta' Malta li toffri servizzi b'rabta ma' Ċittadinanza, Karti tal-Identità, Passaporti, Visi, Espatrijati u Reġistru Pubbliku.

### 2. Għanijiet u baži legali

L-ghanijiet wara l-ċabura ta' informazzjoni permezz ta' din il-formola huma jippermetti l-Unit jivverifika dwar il-persuna mniż-żla fl-applikazzjoni jekk hijiex libera u tkun miżuma b'mod elettroniku fis-sistemi tat-teknoloġija tal-Aġenzija Identità Malta.

Il-baži legali għall-ipproċessar tal-informazzjoni hija t-twettiq ta' kompitu fl-interess pubbliku mil-Aġenzija Identità Malta u b'mod konformi mal-obbligli legali taħt Art. 251 (3), Kap. 16 li l-Aġenzija Identità Malta hija soġġetta għalih. Aħna kburin li nżommu d-data tiegħek sigura u se nieħdu l-miżuri tekniki u organizzatti sabiex inħarsu d-data tiegħek kontra pproċessar mhux awtorizzat jew illegali, inkluz kontra telf, qerda, hażna jew aċċess aċċidental. Id-data personali tiegħek tinżamm f'fajls tal-karti u/jew b'mod elettroniku fuq is-sistemi tat-teknoloġija tagħna.

### 3. Min se jaċċessa l-informazzjoni personali

L-impiegati tal-Aġenzija Identità Malta se jkollhom aċċess għall-informazzjoni personali tiegħek sabiex jipproċessaw din il-formola.

Din l-informazzjoni tista' tkun trasferita lil dipartimenti fi ħdan l-Aġenzija Identità Malta sabiex tiffacilita t-twettiq tas-servizz mitlub permezz tas-sottomissjoni ta' din il-formola.

### 5. Id-drittijiet tiegħek

Għandek ukoll id-dritt li toġġeżżjona għall-ipproċessar tad-data fi kwalunkwe żmien, abbażi ta' sitwazzjonijiet partikolari.

Jekk thoss li l-Aġenzija Identità Malta kissret xi drittijiet dwar il-protezzjoni tad-data tiegħek tista' tissottommetti l-ilment tiegħek lill-awtorità responsabbi fl-Istat Membru fejn inti tgħix, jew fejn inti taħdem, jew lill-awtorità responsabbi fl-Istat Membru fejn allegatament inkissru dawn id-drittijiet.

## PRIVACY POLICY

By submitting the Free Status Application Form and the attachment(s) required (altogether the "Form"), you provide Identity Malta Agency ("IMA") with personal data (the "Data") and thus become a "data subject".

IMA is an Agency of the Government of Malta, delivering services related to Citizenship, Identity Cards, Passports, Visas, Expatriates and Public Registry.

### 2. Purposes and legal basis

The purposes for processing personal data collected within this form are to allow the unit to proceed with the search about the person indicated on the form to be declared free and populating Identity Malta Agency's databases.

The legal basis for processing the Data are the performance of a task carried out in the public interest by Identity Malta and compliance with the legal obligation deriving from Art. 251 (3), Cap. 16 to which Identity Malta is subject.

We take pride in keeping your data secure and will take appropriate technical and organisational measures to protect your data against unauthorised or unlawful processing, including against accidental loss, destruction, storage or access. Your personal data will be stored in paper files and/or electronically on our technology systems.

### 3. Recipients of personal data

Data will be accessed by Identity Malta employees in charge of processing the Form.

It may also be transferred to other departments within Identity Malta in order to facilitate the delivery of the service requested by submitting this Form.

This will be done in line with data protection legislation, and arrangements are in place in order to guarantee the security and lawfulness of these transfers.

Under certain conditions, IMA may disclose your information to other third parties, (such as other Government entities or law enforcement authorities) if it is necessary and proportionate for lawful, specific purposes.

Data will not be transferred to third countries or international organizations.

### 4. Storage period

Data will be retained indefinitely, as prescribed by law.

### 5. Your rights

You can contact the Data Protection Officer in order to exercise your right to access, rectify and, as the case may be, erase the Data, in compliance with applicable laws.

You also have the right to object to the processing of Data at any time, on grounds relating to your particular situation.

If you feel that Identity Malta has infringed your data protection rights, you may submit a complaint to the supervisory authority of the Member State of your habitual residence or place of work, or, alternatively, to the supervisory authority of the Member State where the alleged infringement has taken place.
